### **Recruitment of Residential Medical Officers (RMOs)**

Applications are invited for the Post of Residential Medical Officer for IIIT Nuzvid, Krishna District of RGUKT –A.P either on deputation/lien or on purely contractual basis for a tenure of one year and extendable subject to terms and regulations of University. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the institute OR for continued contractual appointment which may be renewed or terminated as decided by the Institute.

**Posts: Residential Medical Officer – 4 posts.**

### **Qualifications and other details:**

**Candidates with MBBS (PG Degree/ Post Graduate Diploma in Medical holders shall be preferred) from recognized university with appropriate registration as prescribed in the schedule of Medical Council of India (MCI).**

The post of Residential Medical Officers on purely temporary basis on contract on consolidated salary Rs.50,000/- per month with rent free accommodation as per Institute norms. In cases of in-service candidates, the candidates are entitled for protection of last pay drawn. The candidates working in other organizations/ Universities intending to work on deputation should apply through proper channel with a clear no objection certificate from the employer stating that there will not be any objection to relieve the candidate at short notice in case of selection. Retired persons also can apply.

- ✚ **Selection Procedure:** The selection will be on the basis of the interview. The list of selected candidates will be uploaded on website. Candidates are advised to check the Institute website regularly for information
- ✚ The decision of selection committee will be final. No query in this regard will be entertained
- ✚ A candidate who is found to have furnished any particulars which are false or to have suppressed material information, will be disqualified and if appointed, will be liable for dismissal without any notice.
- ✚ If selected you will not be allowed to do private practice or this appointment is whole time and private practice of any kind is prohibited.
- ✚ The employee can also leave the Institute by giving 30 days' notice or salary in lieu thereof'
- ✚ The contract will automatically expire on completion of 12 months until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by the Institute.
- ✚ The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- ✚ The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
- ✚ He/She will have to work in shifts in the Institute.
- ✚ He/She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
- ✚ No travelling or other allowances will be paid to the candidate for joining the post.
