3. The Tender (separate envelopes for technical and commercial bids with labeling) must be submitted sealed cover, superscribing “**Tender for supplying of 25no’s of CCTV’s**”. The name and address of the bidder should also be mentioned at the “From address” space.
4. Address of the firms submitting the quotation/tender and the Officer, to whom the quotation/tender is addressed, must appear distinctly on the sealed cover as under.
