2. The Quotation/Tender Document Fee and EMD should be submitted along with your quotations in a separate envelop.
3. The Tender (separate envelopes for technical and commercial bids with labeling) must be submitted sealed cover, superscribing **“Tender for supplying of White marker boards (Magnetic)”**. The name and address of the bidder should also be mentioned at the “From address” space.
4. Address of the firms submitting the quotation/tender and the Officer, to whom the quotation/tender is addressed, must appear distinctly on the sealed cover as under. Quotation/Tender in must be sealed cover should reach or before 21.01.2019, upto 12 Noon by Courier service/Speed Post/Registered Post/ by person.
