- 2. OEM should be ISO 9001:2000 Certified Company.

3. Tender Cost:

Applicant vendor must submit the demand draft for Rs 2,000/- (Rupees Two thousand only) in favour of "The Director, RGUIIIT, Nuzvid" obtained from any Nationalized/scheduled Bank valid for six months as a tender fees. All applicable bank charges shall be borne by the applicant and he shall not have any claim what so ever on this account on Government. The Demand Draft submitted for tender fee shall be non-refundable.

4. EMD Payment:

The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 30,000/- (Rupees Thirty Thousand Only) by way of demand drafts or Bank Guarantee only. The demand drafts or Bank Guarantee shall be drawn in favour of "The Director, RGUIIIT, Nuzvid". The EMD of the successful bidder shall be returned after the successful submission of Bank Guarantee/ Security Deposit and for unsuccessful bidder(s) it would be returned after the award of the contract.

- 5. a) Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fail to observe and comply with stipulation made herein or backs out after quoting the rates, the amount of earnest money will be forfeited.
- **6. Price**: **Price should be** quoted only in Indian Rupees. The Price quoted should be all inclusive including the installation and admissible taxes. Administrative Officer will not provide any C or D Form. However, subject to availability, way bill / transit permit may be issued.
- 7. Conditional Offer: will not be accepted. No advance is payable against supply of stores
- **8. Period of Validity:** Bids shall remain valid for acceptance, at least for a period of 90 days from the date of opening of the price bid.
- **9.** Technical bid must contain a copy of the commercial bid without the prices.
- **10.** The Administrative Officer does not bind itself to offer any explanation to those bidders whose technical bids have not been found acceptable by the Evaluation Committee of the Administrative Officer.

- **11.** Vendor should clearly mention in their bid, if any specification is not met by the quoted product.
- **12.** Bidders should submit the proforma for technical Bid duly signed with Office seal along with detailed credentials of the Company, Current Income Tax & GST Clearance certificates and other documents supporting the Technical Bid.
- 13. All tenders are to be submitted at the IIIT, Nuzvid RGUKT in the name of "To The Administrative Officer, RGUKT-Nuzvid, Mylavaram Road, Nuzvid, Krishna District, Andhra Pradesh 521201" before the due date and time and acknowledgement to be obtained. In case due date happens to be a holiday, the tender will be accepted on the next working day.

14. IMPORTANT

- (I) The Administrative Officer, IIIT, Nuzvid, RGUKT may accept or reject any or all the bids in part or in full without assigning any reason and does not bind himself to accept the lowest bid.
- (II) The Administrative Officer at its discretion may change the quantity/upgrade the criteria/drop any item or part thereof, at any time before placing the Purchase Order. Administrative Officer at its discretion also reserves the right to verify information submitted and inspect the manufacturer facilities, if required to confirm their capabilities.
 - In case of any dispute, the decision of the Administrative Officer, IIIT, Nuzvid, RGUKT shall be final and binding on the bidders.

Section-V

TERMS AND CONDITIONS

IMPORTANT: READ ALL THE FOLLOWING TERMS AND CONDITIONS AND SIGN THE ACCEPTANCE CLAUSE FOLLOWING IT

- 1) "PRE –BID Meeting" shall be held on 26/02/2019 at 11:00 A.M. at IIIT Nuzvid, RGUKT. All the prospective bidders are requested to send comments/representation on or before pre-bid meeting.
- Rate: Rate should be quoted in Indian Rupees (INR) on DOOR Delivery Basis(supply, Installation and Commissioning) at IIIT Nuzvid, RGUKT inclusive of all the Charges, with break-ups as:
 - Basic Cost
 - ➢ GST
 - ➤ Total Cost (F.O.R. at RGUKT, Nuzvid)

2) Opening of Tender:

The tenderer is at liberty to present either him or authorize not more than one representative to be present at the opening of the tender. The representative present at the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and proof of identification.

3) Validity of the bids:

The bids shall be valid for a period of 180 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid.

4) Amendment of tender document:

At any time prior to the last date of receipt of bids, Institute may for any reason, whether at its own initiative or in response to a clarification requested by prospective bidder, modify the Tender document by an amendment. The Institute may at its own discretion extend the last date for the receipt of bids.

- 5) **Right of acceptance:** IIIT Nuzvid, RGUKT reserve the right to accept or reject any or all tenders /quotations without assigning any reason there of and also does not bind itself to accept the lowest quotation or any tender. Any failure on the part of the contractor to observe the prescribed procedure and any attempt to canvass for the work will prejudice the contractor's quotation or any tender.
- 6) **Signing the Contract:** The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of Rs. 100/- (Rs. One Hundred Only) along with performance security within fifteen days of the issue of the letter of notification of award. In the event of failure on the part of the successful bidder to sign the contract within the period stipulated above, the EMD shall be forfeited and acceptance of the BID shall be considered as cancelled.
- 7) Performance Security: As a guarantee towards due performance and compliance of the contract work, the successful bidder (contractor) will deposit an amount equal to 10% of order value and should be kept valid for a period of 60 days beyond completion of all

the contractual obligation, including CMC period towards security deposit by way of demand draft/ bank Guarantee in favour of "RGUIIIT, Nuzvid "drawn on any Nationalized Bank payable at Nuzvid within fifteen days of the issue of the Letter of notification of award along with non-judicial stamp paper of Rs. 100/- (Contract agreement).

8) **Delivery**:

All the goods ordered shall be delivered at IIIT Nuzvid, RGUKT within 30 days from the date of issue of purchase order. Satisfactory delivery and installation of AC's will be completed within two weeks from the date of receipt of the AC's at the IIIT Nuzvid, RGUKT premises. All the aspects of safe delivery shall be the exclusive responsibility of the supplier. If the supplier fails to deliver the goods on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value shall be levied subject to maximum of 10% of the total order value.

If at any time during the currency of the contract, the supplier encounters conditions hindering timely delivery of the goods and performance of services, the supplier shall promptly inform IIIT Nuzvid, RGUKT in writing about the same and its likely duration and make a request for extension of the delivery schedule accordingly. On receiving the supplier's communication, the institute shall examine the situation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.

9) Liquidated Damages

If the supplier fails to deliver any or all of the goods or fails to perform the service within the time frame(s) incorporated in the tender, the institute shall, without prejudice to other right and remedies available to IIIT Nuzvid, RGUKT under the tender, deduct from the quoted price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods and/or services until actual delivery or performance subject to a maximum of 10 % of the quoted price. Once maximum is reached the institute may consider termination of the tender.

10) Force Majeure:

If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries have been so resumed or not shall be final and conclusive. Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, IIIT Nuzvid, RGUKT party may, at least option to terminate the contract.

11) Insolvency etc.:

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified, the institute shall have the power to terminate the contract without any prior notice.

12) Breach of Terms and Conditions:

In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/ job without assigning any reason thereof and nothing will be payable by the institute. In that event the security deposit shall also stand forfeited.

13) Subletting of Work:

The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of IIIT Nuzvid, RGUKT which will be at liberty to refuse if thinks fit or unfit. The tender is not transferable. Only one tender shall be submitted by one tenderer.

14) Right to call upon information regarding status of work:

The institute will have the right to call upon information regarding status of work/ job at any point of time.

15) **Terms of payment**:

90% Payment shall be released after the successful delivery of the ordered goods against the submission of the Inspection report by the committee. Balance 10% would be made after three months on getting satisfactory certificate from the concerned department.

Only online payment would be done. Hence, details like: Name of the bank, Account No., IFSC code has to be furnished along with the bill.

16) **Arbitration**:

If any difference arises concerning this agreement, its interpretation on payment to be made there under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing Sole Arbitrator to be appointed by the Secretary, Department of Legal Affairs. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

17) Legal Jurisdiction:

The agreement shall be deemed to have been concluded in Nuzvid, Andhra Pradesh and all obligations hereunder shall be deemed to be located at Nuzvid, Andhra Pradesh and Court within Hyderabad will have Jurisdiction to the exclusion of other courts.

. Inspection:

- a) IIIT Nuzvid, RGUKT shall have the right to inspect and/or to test the goods to confirm their conformity to the tender Specifications at no extra cost to IIIT Nuzvid, RGUKT.
- b) The institute reserve the right to inspect, test and where necessary, reject the Goods after the goods have arrived at the final destination and it shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by the institute prior to the goods shipment.

- c) The Director, IIIT Nuzvid, RGUKT shall be the final authority to reject full or any part of the supply which is not conforming to the specification and other terms and conditions.
- d) No payment shall be made for rejected goods. Rejected items must be removed by the bidders within two weeks of the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.

18) **Documents**:

- a) All pages of the Tender should be numbered and indexed.
- b) The bidder shall provide in its tender the required as well as the relevant documents like F data, literature, drawings etc. to establish that the goods and services offered in the tender fully confirm to the goods and services specified by the institute in the tender documents. For this purpose the bidder shall also provide a clause-by-clause commentary on the technical specifications and other technical details incorporated by the institute in the tender documents to establish technical responsiveness of the goods and services offered in its tender duly indicating relevant page numbers in the product literature.
